## **Minutes**

### **1. Introduction & Moment of Silence**

#### **A. Community Update (Standard)**

- T. Canate provided a brief update regarding the statewide HIV Care Needs survey. She reminded the partners that HCSEF staff are available to help clients complete a survey, and the portal will close at the state level on November 30, 2025.
- C. Bonner announced that the HIV Section is no longer looking for a fiduciary agent due to feasibility concerns. C. Bonner also shared that DOH-St. Lucie had a 2% reduction in funding across patient care programs, but C. Bonner noted that the funding reduction should not change operations.
- R. Birks shared that Whole Family Health Center will have an event on December 2, 2025, from 10:00 AM to 2:00 PM. She invited partners interested in tabling to connect with her. She shared that information about the event will be widely distributed to their clients at the next Food is Medicine event, scheduled for Wednesday, November 19th, from 10:00 to 11:30 AM.
