Minutes

1. Introduction & Moment of Silence

A. Community Update (Standard)

- C. Hollinger opened floor for community updates.
 - C. Bonner provided an update regarding restructuring within Department of Health (DOH) in St. Lucie County. She explained that the programs remain the same, but some team members have new supervisory roles.
 - I. Cherry with HIV Prevention shared that the DOH St. Lucie Prevention team has been collaborating with Indian River State College (IRSC) for their Relax and Recharge events. She explained that the DOH St. Lucie Prevention team has been providing educational resources and offering HIV home test kits and condoms to students on the various IRSC campuses. She noted that their next outreach event will be at the Muller Campus on Monday, September 15, 2025 from 11:00 am to 1:00 pm.
 - J. Clarke shared that DOH Martin will be providing educational resources at the Chastain Center in November.
 - T. Canate announced that the Statewide HIV Care Needs Survey has launched and a <u>survey link specific to Area 15</u> has been included in promotional outreach materials. She noted that HCSEF is working to coordinate in-person survey collection in collaboration with community partners.
