## **Minutes**

#### 1. Introduction & Moment of Silence

### 2. Review / Approval of Agenda and Minutes

#### **Discussion:**

#### A. Community Update (Standard)

- M. Talley shared that Midway attended Pride at the St. Lucie County Fairgrounds hosted by The Sanctuary of the Treasure Coast on June <sup>1,</sup> 2025. She noted that Midway administered 11 HIV tests at the event.
- E. Torres and M. Talley commended the event and encouraged the community to get involved in future Pride events.
- C. Bonner noted that the Minority AIDS Coordinator position has been posted. She noted that there were no additional staffing changes.
