2. Review and approval of meeting minutes and agenda (Motion)

3. Lead Agency Report

Lead Agency Staff

Expenditures:

- S. Rangel reported on the closeout of the 2024–2025 fiscal year:
 - o Patient Care Budget: 93% expended (\$2,282,067.64)
 - o Emerging Communities Budget: 82% expended (\$127,329.18)
- S. Rangel explained that the housing budget for the HOPWA program has a fiscal year end date of June 2025 and was 71% expended (\$520,703.97) so far.
- S. Rangel also reported April 2025 spending totals under the new funding year:
 - o Patient Care: \$174,045.10
 - o Emerging Communities: \$7,491.66
- S. Rangel opened the floor to questions. There were no questions from the group.

Quality Assurance Indicators:

- C. Hollinger reported that the 2025 Quality Improvement Project is complete, and a PowerPoint presentation is under review for dissemination.
- C. Hollinger reported updates on the new Quality Improvement metrics:
 - Viral Load Suppression: 25%
 - Medical Visit Frequency: 3%
 - o ART Medication Adherence: 100%
- C. Hollinger noted early-year QI metrics are typically low and expected to improve.
- C. Hollinger opened the floor to questions. No additional questions were asked.
